CISE provides funding as tuition assistance to ten Cincinnati inner-city elementary schools so a solid, faith-based education is available to children as an alternative to the public school. CISE's contribution makes the Catholic school education affordable. All families can take advantage of this. Students are 66% non-Catholic, 88% minority population, and 91% impoverished.

4b (Code:) (Expenses \$ 954,650. including grants of \$ 954,650.) (Revenue \$)**High School Tuition Aid Program**

Tuition aid is provided to 8th grade graduates of the CISE elementary schools to enable them to continue their education at a Catholic high school.

4c (Code:) (Expenses \$ 288,587. including grants of \$) (Revenue \$)**Math Program**

Standardized test scores revealed an opportunity to improve Math achievement. Acknowledging that math becomes more challenging in high school CISE enlisted support from the Hamilton County Educational Services Center. Daily, these coaches consult with CISE teachers, co-teach and examine assessments. They ensure all teachers present math content with confidence and that students are mastering the concepts necessary for high school success. Teachers have welcomed the addition of Math Coaches.

The Finance Committee makes its determinations based on meetings with schools to understand their budgets and ascertain needs. In addition through the provision of scholarships and other financial support to CISE school graduates through the CISE High School Program, CISE will make grants and other distributions to Catholic high schools located within the Archdiocese. CISE keeps records of grants, grant applications, loan paperwork and specific details of other distributions in the form of meeting minutes. CISE requires an application for high school financial aid, but does not require a formal application for the ten elementary schools that it funds on an annual basis. CISE does have annual meetings with each elementary school where the Finance Committee/CISE Executive Director and school leadership review the schools' current budget projections for the next year, discuss financial needs, and accountability for use of the funds. CISE requires annual budget meetings between the CISE Finance Committee and leadership at the ten elementary schools. In
